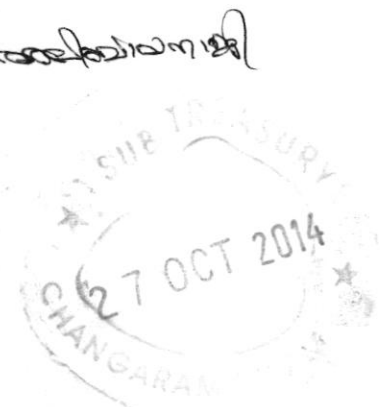

1.NAME

The name of Trust shall be Malabar Educational & Charitable Trust and Trust office shall be situated at 8/684 Crescent Plaza, Edapal Malappuram Dist. Kerala State South India and the term trustee shall mean Trustees of the said Malabar Educational & Charitable Trust.

2.MAIN OBJECT

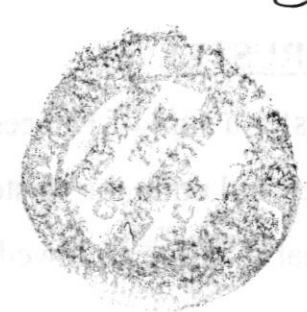

- B. The founder of the trust shall hold office for life. The other trustees shall hold office for five years. The trustees may co opt to the Board of Trustees, if necessary, any other person to make the total number to fifteen.
- C. The Trustee co-opted shall hold office only for 5 years and liable for retirement. The Trustees whose term of office expires after the period 5 years are eligible to be co-opted as trustee again by Managing Trustee. The Trustee may if they desire so can resign the trusteeship even before the expiry of the term of their trusteeship.

D. OFFICE BEARES

Chanthaparambil Alibava Haji the founder of the trust shall be the Chairman and Managing Trustee of the trust for life. He shall have the power and right to nominate his successor in office who shall take his place as Managing Trustee either during his life time or after his death as he may choose to decide in writing. The Managing Trustee shall act as Chairman and preside at all the meeting of the Trust Valiyavalappil Fathima W/o Chanthaparambil Alibava Haji shall be the Secretary of the Trust and Uthwanganakam enna Maliyekkal Fathima W/o Chanthaparambil Alibava Haji shall be the Treasurer of the Trust.

5. MEETING OF THE BOARD OF TRUSTEES

In the absence of Managing Trustee at any meeting, as Trustee duly authorized by the MANAGING TRUSTEE can convene a meeting of Trustees and preside over the meeting. The quorum of the Board of Trustee and the execute committee shall be 50%. 6. POWERS & DUTIES OF MANAGING TRUSTEE

Subject to the provision of the Act, and to the general supervision and control of the Board of Trustee the Managing Trustee shall have the general direction, management and superintendence of the activities of the Trust with power to do all acts, matters and things deemed necessary, proper or expedient for carrying on the activities and concern of the Trust. The Managaing Trustee shall have power to appoint, suspend, and dismiss officer, staff and workmen of the Trust, to make and sign all contracts and receipts, and to draw, accept, endorse and negotiate on behalf of the Trust all such bills of exchange, promissory notes, cheques, drafts and all other instruments as shall be necessary, proper or expedient for carrying on the activities of the Trust. The managing trustee shall have the power to operate on the bank account, and do represent the Trust in all suits, and all the legal proceedings and sing necessary papers, documents and instruments of the authority and generally to exercise all such powers and authorities as noted by the Act for the time being in force or by this Trusts Deed expressly directed to the exercised by the Board of Trustees or the Trust in general meeting.

6A. POWERS AND DUTIES OF BOARD OF TRUSTEES

- a) The Trust may receive donations of money and/or properties and when received shall be at the absolute disposal of the Trust.
- b) The Trustee shall invest the properties and monies of the trust in such manner as prescribed under Section 11 of the Income Tax Act 1961 and other statutory laws.
- c) The Board trustee shall mett as often as necessary in any resolution to be passed touching the administration of the Trust, the opinionof the majority shall prevail. It shall be competent however for the trustee to decide matters by circula

tion. In case there being equality of votes, the chairman has casting vote for the purpose of deciding the issue.


- d) The trustees may open and operate current/saving account or deposit in any bank or banks and by resolution authorized by one person or more of the trustee either by singly or severly to operate such accounts.
- e) The Board may by resolution extent the activites of the Trust or under take any activity in furtherance of the main object of the Trust.
- f) Proper books of accounts of the Trust shall be maintained and it must be audited by Chartered Accountant.
- g) To do such other lawful things which are incidental in carrying out the administration and management of the Trust.
- i) The Board of trustees shall have power to remove any trustee from the trust, if it is found that his/her activites are not conducive to the interest of the trust or are opposed to the attainment of any of the objectives of the Trust, or he/or she become insanem declared as pauper or convicted by court in criminal case at a meeting of the Board of Trustee specially convened for this purpose and by a Resolution approved by tow/third of the total numbers of the Trustees.
- j) The trustees if and when deemed fit by them shall delegate their responsibility, rights, and power in clause of the Deed to an Executive Committee elected among themselves. The Trustee by simple majority shall have the right to suspned, or terminate, the said executive committee at any time of their choice.
- k) The trustees if and when deemed fit by them shall delegate their responsibilitiy power, privileges ad defined in the clauses of this Deed to sub committee elected from among themselves or from the benefcators of the Trust or eminent, per son of high academic qualifications and ability to organize and implement

- l) The Board of Trustee shall have power to accept the Trusteeship or management of any other trust, association, organization, or endowment and such trust, association, organization or endowment shall be administered in consonance with the provision of this Deed.
- m) The Board of Trustees shall have power to accept or receive all loans, endowments, gifts, grants, or donations, movable or immovable properties made to this Trust by assignment, or otherwise by individuals, groups, banks, financial corporations, organizations or associations, whether incorporated or not or by any government and all such endowment, gifts, grants, donations shall become the property of the Trust and shall be administered for pursuing the aims and objectives of this Trust and accordance with the provision of this Deed.
- n) The Board of Trustee shall not have power to sell or dispose off the properties of the Trust or any other property thereof, except in case of absolute necessary or for purchasing properties more useful and/or beneficial to the Trust and except with the approval of at least two-third of the existing Trustees. The Trustees shall however, have the power to pawn, pledge, or mortgage the Trust properties in order to raise funds or loan to carry out the objectives of the Trust. No such pawn, pledge, or mortgage shall be valid unless made with the approval of at least two-third of the existing Trustees.

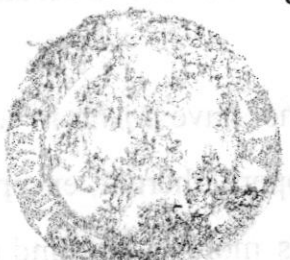

- o) The Board of trustee shall appoint the necessary staff employees and other official for the functioning of the trust and shall have the power to decide all matters relating to such appointment and other relevant factors in connection therewith. - p) All investment and properties belonging to the Trust shall be held either in the name of the Trust or in the name of Managing Trustee only.
- q) The Board of Trustees shall have the power to prescribe additional rules and by-laws to amend or delete the existing provision of the Deed, without being changes to the charitable and social nature of this Deed. Such additions, deletions, or amendments shall however be subjet to the approval of three-fourth of the existing Trustee.
- r) In case of any dispute, arise among the Trustees, the matter may be refferred to an ARBITRATOR appointed by the Board of Trustees of that period, and the decision of the Arbitrator shall be final. And dispute regarding election, administration, appointments of committee or their decisions, constitution, or its amendments of the Trust the matters will be referred to Arbitratot and CAN NOT be referred to any Civil Court. - 10) In all other matters not specifically provided for herein, the Trustee shall function in accordance with the provision of the Income Tax Act.
- 11) Subject to the provisions hereof the income and asset of the trust shall be used only for the charitable purposes mentioned herein and no part of the income shall ensure to or shall be used applied directly or indirectly for the benefit of any person referred to section 13(3) of the Income Tax Act 1961 or any statutory modification thereof.
